The city has a total quota of 46 licenses as of the 2000 Census.

- * The licenses that are issued for C & P Mine, Duke Humphries', Geo's Deli, Rochester Hills Golf Club, and Club Hawthorne will remain in the city's quota number even though they have been transferred out of the city. Alfoccino's and WhirlyBall remain available in the city at this time.
- Bill Knapp's Restaurant (originally at Walton & Adams) had a Class C license in 2002 but was returned to our quota (per Lindsay from LCC 1/27/03).
- Rustica Europa's (877 E. Auburn) Class C license had been held in escrow and was returned to our un-issued quota this year.
- Outback is a Class C that is transferred in from another community and is not counted with our quota
- Check Mate Stix, previously held in escrow has been transferred and is now CJ Mahoney's.
