Dear Ms. Farris:

Thank you for considering our proposal to continue providing audit services to the City of Rochester Hills. The purpose of this communication is to modify our proposed fees for providing audit services.

As described in a separate communication that we have provided to the Mayor and Members of the City Council, eight new auditing standards have been issued (Statements on Auditing Standards 104 through 111) that require significant changes in how audits are performed, beginning with the City's December 31, 2007 financial statements. We have evaluated the additional effort that we expect to incur in the upcoming audits. As demonstrated in the attached schedules, our best estimate is that we will incur additional costs of \$12,000 in this first year, including the audits of the City, the Older Persons' Commission and Rochester-Avon Recreation Authority. In the second year (calendar 2008 audit), we expect this added effort to decrease to \$5,000 and remain consistent at that amount for 2009. In order to minimize the budget impact of these increases, we have prepared an amended fee quote that spreads these costs over a three-year period. Since our most recent fee proposal covered audit years through 2008, we have included a total fee for the 2009 audit using an inflationary increase to the 2008 fee as originally quoted plus the increase for SAS 104-11. As such, we would like to propose the following amended fee schedule:
