Request for Purchase Authorization-DPS/Engineering: Traffic Signal Maintenance and Repairs and/or Upgrades of existing traffic signals, FAST-TRAC/SCATS system, school flashers, and LED traffic signal upgrades. blanket purchase order increase to a new not-to-exceed total of \$230,000.00;Road Commission for Oakland County, Waterford, MI.

Whereas, that City Council authorize the increase of the Road Commission for Oakland County blanket purchase order for costs associated with Maintenance, repair and/or upgrades of existing traffic signals, FAST-TRAC/SCATS system, school flashers, and LED traffic signal upgrades in the amount of \$80,000.00, and

Whereas, that City Council authorize an additional amount for costs associated with four illuminated overhead crosswalk signs and four street lights as part of the Clinton River Rails to Trails Project in the amount of \$50,000.00.

Resolved, that the Rochester Hills City Council increase the blanket purchase order to Road Commission for Oakland County by \$130,000.00 to a new not-to-exceed amount of \$230,000.00 and authorized the Mayor and Clerk to execute the agreements for the illuminated crosswalk sign installation on behalf of the City.
