SUBJECT:	Landscaping Services (Lawn Mowing) 2005

#### **REQUEST:**

City Council is requested to authorize the issuance of a blanket purchase order to Lead Outdoor Services, LLC, Warren, Michigan, for lawn mowing and landscape services for City-owned sites in the amount not-to-exceed Fifty-Two (\$52,000) Thousand Dollars, for a period of one (1) year, with the option to renew for an additional one (1) year period.

#### **REASON FOR PURCHASE:**

On February 23, 2005, the City received proposals from qualified and experienced companies to provide supervision, labor, equipment, services and expertise required to perform landscaping services, including lawn mowing and shrub trimming at various City locations for the 2005 season; the City reserves the right to exercise an option to renew for one additional 1-year period.

The allocations of costs for the various City sites are depicted in the attached spreadsheet. The not-to-exceed amount also includes funds to account for additional mowing due to weather conditions and other City events.

After review and evaluation of the proposals, Lead Outdoor Services was selected as providing the best value and lowest cost proposed for lawn mowing and landscaping services for the City. References contacted reported satisfaction with services provided.
