SUBJECT: Hamlin Road Widening between Crooks to Livernois; 1998 Rochester Industrial Dr.

REOUEST:

City Council is requested to authorize payment in the amount of \$ 5,000.00 to Oakland University Medical School on behalf of Mr. Alan T. Ackerman, attorney that represented Collex Collision during the Hamlin Road Widening project between Crooks and Livernois.

REASON FOR PURCHASE:

The Hamlin Road widening project needed to acquire right-of-way from adjacent property owners. Mr. Ackerman spent time representing his client Gagliano Enterprises, LLC (Collex Collision) during the highway easement acquisition process. City Attorney, John Staran, corresponded with Mr. Ackerman during the prolonged easement negotiation period and mutually agreed upon a recommended compensation for Mr. Ackerman's involvement to avoid resolution via the court system. Mr. Ackerman agreed to have his compensation submitted as a donation to either the Oakland University Medical School or the University of Michigan Law School in lieu of the City paying him the \$5,000.00 directly.
