SUBJECT:	Re-Roofing Projects at Rochester Hills Museum at Van Hoosen Farm	

REQUEST:

City Council authorization for a re-roofing project at Rochester Hills Museum at Van Hoosen Farm for construction services in the amount of \$58,200 with a 20% contingency (\$11,640) to Butcher & Baecker Construction Company, Rochester Hills, Michigan, and for architectural/engineering fees in the amount of \$5,000 to THA Architects Engineers, Flint, Michigan for a total project budget of \$74,840.

REASON FOR PURCHASE:

The Van Hoosen Farmhouse was re-roofed in 1985, as part of a major exterior renovation. For the past ten years, the Farmhouse has had extensive damage due to ice damming problems in the winter that has affected the historic plaster and wallpaper inside the building. In addition, many of the shingles have warped and cupped. While there have been numerous spot repairs, the replacement of the shingles was identified in the THA evaluation report of City buildings in 2001. To repair the problems with ice damming, a new ice and water shield will be installed under the shingles, additional ventilation added and the shingles will be treated with a fire proof retardant chemical.

The Red House was re-shingled with cedar shingles in 1996. At that time a small portion of the roof was identified as having a swale in the roofline, however, the swale was not repaired because no structural flaw was detected. Unfortunately, the swale does not shed water effectively, and extensive ice damming and damage has occurred inside the Red House. The small rooms under this roof section have been closed to the public for over a year, waiting for these repairs to be completed. New shingles will be added, as well as a new ventilation system, new roof trusses, additional insulation and an ice and water shield will be installed under the shingles.

Plaster repair in both buildings will be pursued once the roof repairs are complete.

The gazebo singles were installed in 1987, and have decayed due to moss growth. All new shingles will contain fire proof material and moss proof chemicals impregnated into the shingles.

Request for Proposals were solicited and proposals were reviewed and evaluated by an evaluation committee, consisting of Pat McKay, Alan Buckenmeyer, Bob Srogi, Jackie Hoist (THA Architects Engineers) and Jean Farris. Butcher and Baecker Construction Company was selected based on the lowest cost proposal and best value for the City. Butcher and Baecker Construction is a qualified contractor with experienced and certified staff relative to both cedar shingles and historical buildings. The company has performed prior re-roofing services at Bloomer Park and other Van Hoosen Farm buildings to the satisfaction of the City.

The following is a breakdown of the costs for the re-roofing project:

*City Council is requested to approve a 20% contingency on this project due to the unique and historical nature of the structures and the unknown conditions that may be discovered during the course of the project.
