### **OPTION - STATUS QUO**

*Now, Therefore, Be It Resolved* that the Administration & Information Services (AIS) Committee recommends to City Council that the compensation for the Rochester Hills City Council, in the form of a yearly salary for the 2006 Fiscal Year remain the same as Fiscal Year 2005 as follows:

City Council President - \$7,850.48/year

City Council Member - \$6,577.43/year

**Be It Further Resolved** that the AIS Committee recommends that City Council Members shall receive per diem compensation in the amount of Sixty Dollars (\$60.00) for attendance at any meeting, for which they are appointed as a Council Representative, in excess of Thirty-two (32) meetings per year.

#### **OPTION 2 - CHANGE MEETINGS FROM 32 MEETINGS TO 25 MEETINGS:**

*Now, Therefore, Be It Resolved* that the Administration & Information Services (AIS) Committee recommends to City Council that the compensation for the Rochester Hills City Council, in the form of a yearly salary for the 2006 Fiscal Year remain the same as Fiscal Year 2005 as follows:

City Council President - \$7,850.48/year City Council Member - \$6,577.43/year

**Be It Further Resolved** that the AIS Committee recommends that City Council Members shall receive per diem compensation in the amount of Sixty Dollars (\$60.00) for attendance at any meeting, for which they are appointed as a Council Representative, in excess of Twenty-five (25) meetings per year.

## **OPTION 3 - RECOMMEND TO DEFER**

Now, Therefore, Be It Resolved that the Administration and Information Services (AIS) Committee requests City Council waive Article V, Compensation for Members of City Council, Sections 3 and 4 of the City Council Policy for Salaries of Department Directors and Mayor and Per Diem Fees for Boards and Commissions and defer setting the 2006 City Council compensation until such time a recommendation is received from the Administration and Information Services Committee.

**Be It Further Resolved** that the AIS Committee shall make a recommendation to City Council prior to the final approval of the 2006 budget.
