**REQUEST:**

Concur with the recommendations of the Administration & Information Services (AIS) Committee for the Per Diem Fees for the City's Boards and Commissions for fiscal year 2006.

**DISCUSSION**

Pursuant to Section 8.8 of the City Charter of the City of Rochester Hills, City Council is required to set in the annual budget, by resolution, the annual salary for the Department Directors and the rates of compensation for Members of Boards & Commissions.

As directed by the *City Council Policy for salaries of Department Directors and Mayor, and Per Diem Fees for City Boards and Commissions*, the AIS Committee has reviewed the appropriate information and at its Regular Meeting of June 7, 2005 adopted the following resolution:

A motion was made by Dalton, seconded by Hill that this matter be recommended for Approval:

***Resolved*** that the Administration & Information Services Committee recommends to City Council that the rate of pay for the Boards and Commissions for the Fiscal Year 2006 Budget remain the same as Fiscal Year 2005 and be set at Seventy-Five Dollars (\$75.00) for the Chairperson, and Sixty-Five Dollars (\$65.00) for the Members per meeting.
