AMENDMENT TO WATER MAIN EASEMENT

On the 9th day of April, 1996, Michigan Christian College, whose address is 800 West Avon Road, Rochester Hills, Michigan 48307, granted an easement for a water main favoring the city of Rochester Hills, Michigan, whose address is 1000 Rochester Hills Drive, Rochester Hills, Michigan 48309, as recorded on November 4, 1996, in Liber 16736, Page 686, Oakland County Records (hereinafter referred to as the "Existing Easement"). The legal description of the original recorded easement is:

A 12-foot wide easement for water main centered on the water main as constructed across the following described line: commencing at the south ¼ corner of Section 15, T3N., R11E., the city of Rochester Hills, Oakland County, Michigan; thence due West 12.05 feet to the point of beginning; thence due North 147.84 feet; thence N.45°00'00"E 67.92 feet; thence due North 391.56 feet; thence N.10°31'59"W. 67.07 feet to a reference point "A"; thence continuing N.10°31'59W. 148.66 feet to a reference point "B"; thence continuing N.10°31'59"W. 34.25 feet; thence N.57°17'33"W. 62.21 feet; thence S.81°32'49"W. 18.07 feet; thence S.40°23'11"W. 59.28 feet to a reference point "C"; thence continuing S.40°23'11"W. 230.02 feet; thence S.60°20'17"W. 65.58 feet to a reference point "D"; thence continuing S60°20'17"W. 156.46 feet thence S.15°20'17"W. 20.05 feet; thence S.29°39'43"E. 117.74 feet to a reference point "E"; thence continuing S.29°39'43"E. 7.74 feet; thence S.15°20'14"W. 5.86 feet; thence S.60°20'17"W. 95.74 feet; thence S.15°16'03"W. 13.33 feet; thence S.29°48'12"E. 55.42 feet to a reference point "F"; thence continuing S.29°48'12"E. 44.36 feet; thence S.00°17'28"W. 253.07 feet to a point of ending at the south line of Section 15, said point of ending being distant 443.50' due West from the S.1/4 corner of Section 15.

And beginning at the reference point "A", thence S. 79°56'45"W. 39.95 feet to a point of ending.

And beginning at the reference point "B"; thence N.79°28'01"E. 37.88 feet to a point of ending.

And beginning at the reference point "C"; thence N.49°36'49"W. 111.49 feet to a point of ending.

And beginning at the reference point "D"; thence N.29°39'43"W. 77.51 feet to a point of ending.

And beginning at the reference point "E"; thence $N.60^{\circ}16'18$ "E. 187.26 feet; thence $N.15^{\circ}19'46$ "E. 16.99 feet; thence $N.32^{\circ}51'58$ "W. 9.12 feet to a point of ending.

And beginning at the reference point "F"; thence S.60°11'48"W. 10.67 feet to a point of ending. Pathway easement: the northerly 10 feet of the southerly 60' of the above described parcel of land.

Subsequent to the creation of that water main easement, Michigan Christian College changed its name to Rochester College as of June 30, 1997.

On the 16th day of November 2001, the city of Rochester Hills and Rochester College amended the easement, as recorded on April 16, 2002 in Liber 25379, Page 509, Oakland County records.

Currently, Rochester College is commencing construction of an addition to the library building on the subject property such that it is now necessary to relocate the water main.

The city of Rochester Hills and the Rochester College wish to amend the legal description of the easement to describe its new location.

Based on these facts and circumstances, the parties agreed to and by this document amend the existing easement so that the following legal description shall replace and supercede the legal description of the existing easement as originally recorded and amended, the originally recorded and amended legal description for the existing easement shall be of no further force or effect and the city of Rochester Hills, Michigan, shall have those same easement rights in the following described easement.

A 20-foot wide easement, which is part of Parcels 15-15-376-001 and 15-15-451-003, the centerline being more particularly described as follows:


