2019-0076 Judson Park Turning Restrictions Review

Allan Schneck stated that the request came from the neighborhood and the study was performed for cut-through traffic. The study did warrant the turning prohibition signs placed on Brewster and Roseview for a temporary TCO. Mr. Davis talked with Mr. Quail and they agreed the signs were effective and they have decided to keep the signs. Mr. Quail stated he only heard positive feedback, no negative comments. Residents asked how many tickets were issued. Detective Shimmell stated that there was a two-week grace period and then assigned cars were giving out warnings. Around a dozen tickets were issued. The neighborhood residents appreciated the attention. Mr. Colling stated the traffic is going onto Shenandoah from Tienken. The traffic in the cut-through study was identified as school traffic so it dissipated after 20 minutes. Some people are concerned with the amount of traffic on Tienken. A resident asked it the permanent signs will replace the temporary signs and if there will be a reduced speed ahead sign. Schneck stated we can make note of it. Mr. Colling stated we will need to keep an eye on it through the next school year. Quail stated that he heard as much about Adams as he has about the subdivision. Mr. Colling stated that we should revisit. Mr. Schneck stated that the school has hired an engineer from WSP, a highly respected engineering firm. Mr. Schneck stated we met with the school, we did some traffic counts and a synchro analysis which shows how the operation of the street works based on traffic volume. One of the big concerns is east bound traffic in the morning turning into Highlander Drive which is the most westerly entrance to the school. There were so many left turns that they didn't have enough stacking that it spilled out into the through lane. We partnered with the school to extend the left turn lane which allows traffic traveling eastbound to continue through.

Mr. Colling asked what the consultant's purpose is. Mr. Schneck stated there is still a concern there. We put up traffic signs because people are still flying through there so we wanted to slow traffic down. We are working with the school district to install traffic lights to illuminate the entrances. We are looking at on-site circulation. If we can get the cars off Tienken and get them on-site it would be so much better. We are also looking at staggering school start times between Adams and Van Hoosen. Mr. Collig asked if the consultant more concerned with the school or surrounding roads? Mr. Schneck stated we are partnering with the school to look at everything. Mr. Depp stated that the school board needs to figure out how to fix the issues with the money they have.
