WHEREAS, under the provisions of Chapter VI of Act No. 300, Public Acts of Michigan of 1949, as amended (Michigan Vehicle Code), this Board is authorized to place and maintain traffic control devices and traffic control signals on any highway under its jurisdiction for the purpose of regulating, warning or guiding traffic; and

WHEREAS, Grosse Pines Drive and Chalmers Drive, located in Section 9, Avon Township are county roads under the jurisdiction of this Board and, in the interest of public safety, it is deemed necessary to place and maintain certain traffic control devices and/or signals on said roads to regulate, warn or guide traffic.

NOW, THEREFORE, BE IT RESOLVED, that the following roads are designated as through roads and all vehicles approaching these roads are required to stop before entering with those exceptions as noted.

- 1. Chalmers Drive from Wintergreen Drive east and north to Shorebrook Drive except at Grosse Pines Drive (south intersection) which must yield to Chalmers Drive. (see YS 171-2-80)
- 2. Grosse Pines Drive from Grosse Pines Court south to Chalmers Drive (north intersection) except at Vianne Drive (west intersection) and Marcastle Court which must yield to Grosse Pines Drive. (see YS 171-2-80)

BE IT FURTHER RESOLVED, that stop signs shall be erected to give notice of the regulation hereinbefore established; and

BE IT FURTHER RESOLVED, that a certified copy hereof be filed with the County Clerk of the County of Oakland, Michigan.
