## **PUBLIC COMMENT**

**Mr. Lee Zendel**, 1575 Dutton, gave departing comments to the exiting Council members and stated that he hoped that they would continue their civic involvement.

**Ms. Linda Davis-Kirksey**, 1337 North Acre Dr., thanked the exiting Council members for their contribution to the City for the past eight years.

**Mr. David Kibby**, 558 Whitney, expressed his concern as to how he felt some candidates ran their campaign.

**Mr. Tim Greimel**, Oakland County Commissioner, congratulated all of the new Council members and the Mayor on their success in the November Election. He informed Council of a new County program called "Community of Home Improvement Division" that has two Mortgage Counselors available to provide free mortgage counseling to any resident who is having trouble paying their mortgage. He stated the Community of Home Improvement Division provides services such as:

1) Very low interest loans for home improvements or repairs for low and middle-income residents.

2) Available monies of up to \$10,000 to assist qualified first time home buyers with a down payment on a home.

## **LEGISLATIVE & ADMINISTRATIVE COMMENTS**

**Ms. Holder** advised that this was the ninth year that Holiday Helpers assisted families in need in the City of Rochester Hills. She stated that there was a "Gift Giving Tree" displayed at City Hall for any resident desiring to help others in need.

**Mr. Ambrozaitis** stated he was thankful to serve the residents in District 4.

**Mr. Hooper** advised that the Rochester/Auburn Hills Community Coalition has obtained the services of Milton Creagh to give two presentations in this community. The first presentation will be held at the Avondale Middle School Cafetorium on Wednesday, November 28, 2007 at 7:00 p.m. and the theme will be "Parenting is the Key"; the second presentation will be held at the Rochester High School Auditorium on Thursday, November 29, 2007 at 7:00 p.m. and the theme is "Wiz of a Wiz" which is a motivational talk for parents to build positive bridges in the community.

**Ms. Raschke** stated that Brookwood Subdivision held its second annual "Make a Difference Day" Flea Market and raised approximately \$10,500, then donated the proceeds to the Baldwin Soup Kitchen.

**Ms. Angie Jackson**, Rochester Hills Government Youth Council Representative, stated the Youth Council is currently working on hosting a Youth Summit in the Spring of 2008 and hoped to attract Youth Councils from all over Michigan to participate. She advised their goal is to increase youth participation in the community and inspire youth leadership.

**Mayor Barnett** stated "Santa Claus" would be coming to Rochester Hills with the "Lighting of the Tree" celebration in the Village of Rochester Hills. He further stated that Adams High School was competing for the State Football Championship and that they were participating in a State Semi-Finalist game in Ferndale on Friday, November 16, 2007. He informed Council of the resignation of Mr. Ken Johnson, City Administrator for the City of Rochester for the past 29 years. He wished Mr. Johnson the best in his retirement.
