Paul discussed the speed study for the Thornridge subdivision completed for the HOA group that wanted the CITY to look into speed humps. The traffic study concluded that Olympia and Charlwood did not meet the median threshold for speed hump installs. The results were related to the HOA and it was suggested that the HOA ask the Sherriff's office for speed carts. Traffic enforcement can also be utilized.

The next study was performed on Cross Creek Boulevard at the request of the HOA. The results of the traffic study says that Cross Creek does meet the threshold for having speed humps installed. We would be open to installing a speed hump if the HOA wants to proceed with that. The decision to proceed is with the HOA at this point. The difficulty is that our traffic calming policy states that we need 100% agreement from the homeowners adjacent to where the speed hump will be installed to support it. If one doesn't want it we need to find a different location. We can usually find a location and have the homeowners sign off on it. We usually recommended 300-400 feet on a straight away section.
