**SUBJECT:** Snow Removal Services (2005-2006) at City Hall, Precinct #5; and 1700 & 1600 Hamlin West

# **REQUEST:**

City Council is requested to authorize the issuance of a blanket purchase order to Steele's Services, LLC, Rochester Hills, Michigan, for snow removal services for the 2005-2006 winter season at City Hall, Precinct #5; and 1700 & 1600 Hamlin West in the amount not-to-exceed Thirty-One Thousand One Hundred Thirty-Three (\$31,133) Dollars, by exercising an option to renew for the period of one (1) year to expire on October 15, 2006.

# **REASON FOR PURCHASE:**

It is important to the City to provide a safe environment for persons accessing City buildings during the winter months. Competitive sealed bids for Snow Removal Services at City Hall, Precinct #5; and 1700 & 1600 Hamlin West were solicited and opened on September 18, 2003. Steele's Services, LLC, was selected as the lowest responsive, responsible bidder based on a comparison of costs per bidder. The bid contained an option for the City to renew for the 2005-2006 winter season. Last year, Steele's Services performed snow removal services satisfactorily; therefore, it is the City's desire to exercise its option to renew for an additional 1-year period.

Snow removal services for the 52/3 District Court and Sheriff Substation will be presented to Council separately. Snow removal at remaining City facilities will be completed by City personnel. Note: In the event that the Hamlin property is sold, the contract contains a clause indicating the City may delete sites with a thirty (30) day notice.

### **Vendor Name and Address:**

Steele's Services LLC 2230 Star Court Rochester Hills, MI 48309

#### **Reason for Selection:**

Best value and lowest cost.

### **Method of Purchase:**

1-year blanket purchase order by the City exercising its option to renew for an additional 1-year period.

### **BUDGET:**

Funding for Snow Removal Services will be taken from the Facilities Division for multiple years. A Budget Amendment may become necessary, depending upon the severity of the winter weather.

It is recommended that the Rochester Hills City Council award the contract for Snow Removal Services at City Hall, Precinct #5; and 1700 & 1600 Hamlin West for the 2005-2006 winter seasons by authorizing the City to exercise its option to renew for an additional 1-year period to **Steele's Services**, **LLC**, **Rochester Hills**, **Michigan**, as the lowest, responsive, responsible bidder, in the amount not-to-exceed Thirty Thousand One Hundred Thirty-Three (\$31,133) Dollars through October 15, 2006.
