## **REQUEST:**

City Council is requested to authorize a purchase order for one (1) new 2009 Trackless MT6 articulated municipal tractor to Fredrickson Supply, LLC, Wyoming, Michigan in the amount of \$103,100.00.

## **REASON FOR PURCHASE:**

Bids for the purchase of one (1) new articulated municipal tractor were solicited and received. Fredrickson Supply was concluded to be the lowest, responsive, responsible bidder to meet the City's specifications. The actual low bidder, Bell Equipment Company took exceptions to the bid specifications.

The municipal tractor is used year round by the Department of Public Service for intersection maintenance of major and local roads, and for winter bike path maintenance. This machine will replace the City's current 1999 Holder 9700 municipal tractor that is fully depreciated and in need of replacement. The Holder 9700 cab doors are severely rusted and in need of replacement. The machine is also in need of two (2) tires and numerous smaller maintenance items that need to be replaced. The front lift quadrant has been repaired many times and also will require replacement soon. The Holder 9700 will be traded-in and the value of the trade-in is \$10,000.00.
