SUBJECT: Nawakwa Road Resurfacing Project, E10-003

REQUEST:

The Department of Public Services recommends awarding the contract for the Nawakwa Road Resurfacing Project to Pro-Line Asphalt Paving Corp. of Washington, Michigan in the amount of \$221,734.00 and authorizes the Mayor and Clerk to execute a contract on behalf of the City.

The Department of Public Services also requests City Council authorization of a 10% contingency in the amount of \$22,173.40 to allow for quantity adjustments based on final measurements verified in the field.

REASON FOR PURCHASE:

On Wednesday, September 8, 2010, the City received eight (8) sealed bids for the Nawakwa Road Resurfacing Project (bid tabs attached). Of the eight (8) bids received, Pro-Line Asphalt Paving Corp. was the lowest responsive, responsible bidder.

The Scope of Work for this project includes: HMA pavement removal (milling); placement of 1-1/2" HMA over existing pavement; approximately 1,300 feet of pavement removal and replacement prior to resurfacing; selective concrete curb & gutter removal and replacement; construction of ADA compliant pathway-sidewalk ramps; restoration; and other miscellaneous items of work.
