SUBJECT: Fan Ventilation Equipment and Installation for Borden Park Maintenance Building

REQUEST:

City Council is requested to authorize a purchase order for the purchase and installation of fan ventilation equipment for the Borden Park Maintenance Building to Design & Quality Electric, Inc. of Rochester, Michigan, in the amount of \$8,578.00.

REASON FOR PURCHASE:

Quotes were solicited for the equipment and installation of fan ventilation equipment at the Borden Park Maintenance building. The work calls for ceiling and exhaust fans and the necessary electrical work to install all equipment. This equipment will be installed to improve air quality and improve heating efficiency for maintenance operations.

Dust and exhaust fumes are generated during routine maintenance operations such as sanding, grinding, welding, cutting and touch-up painting. Diesel and gasoline fumes coming from small engines, mowers and material handling, build up in the ceiling area and are not exhausted. Pre-warming engines is another source of fumes. These pollutants need to be exhausted from the building to improve the air quality and for the long-term health of employees. Currently the only means off removing fumes and dust are to open the large garage bay doors. In order to completely remove the dust and fumes requires that the doors remain open for a long period of time compromising the security of the equipment stored in the building in the Summer and allowing huge heat losses in the Winter.

The fans will improve heating efficiency by being able to keep the large garage bay doors closed during the winter and circulating heat from the high ceilings to the work area. They will also help to dissipate the extreme heat build up during the summer.
