**SUBJECT:** Amendment to the Oakland County Sheriff's Department Law Enforcement Services Agreement to add a Patrol Sergeant

---

**REQUEST:**

To request the Administration to execute an amendment to the current Oakland County Sheriff's Department 2004-2008 Law Enforcement Services Agreement to add a Patrol Sergeant.

**REASON FOR PURCHASE:**

During the 2006 Budget Work Session discussions for the Police Services Fund, City Council discussed the benefits of adding a Patrol Sergeant to the Rochester Hills substation. City Council approved the budget for a program that would allow for a new Patrol Sergeant to be responsible for shift supervision and be considered a "working-deputy". This would allow for an existing Deputy II position to administer the False Alarm Ordinance program, in an attempt to reduce the number of frivolous false alarm calls, which currently occupy a good amount of the Sheriff's Department time. False Alarm fees will be intended to deter/reduce the number of false alarms allowing deputies to attend to more important police matters. The Sheriff's Department estimates that there will be some offsetting City revenue generated from implementing a False Alarm Program, yet revenue generation is not the driving force behind the program. An additional Patrol Sergeant would increase the number of contracted Sheriff's Department personnel from 58 to 59. Monies in the amount of \$116,472.00 have been appropriated in the 2006 Budget for an additional Patrol Sergeant position.
