

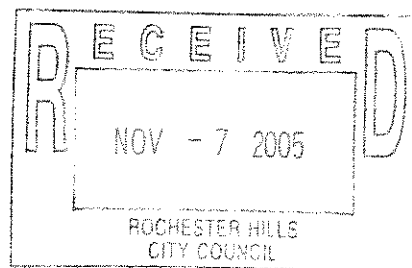
Finally, I am a very strong communicator, and believe that communication – with the Council, with city employees and most importantly with our fellow citizens – will be critical to our success.


