SUBJECT: No Haz Agreement for 2006

REQUEST:

City Council is requested to authorize the Mayor to enter into the North Oakland County Household Hazardous Waste (No-Haz) 2006 Inter-local agreement between Oakland County and The City of Rochester Hills, including a total administrative cost not-to-exceed \$45,000.00.

REASON FOR PURCHASE:

Entering the fourth year, Oakland County is continuing its coordination and facilitation in an agreement with North Oakland County communities in order to form a comprehensive household hazardous waste management program. This program is intended to provide consistent, reliable and convenient access to collection services for residents of northern Oakland County. This program will also assist in further reducing toxic materials from entering waterways and landfills. An educational program will also continue to inform residents about the disposal and reduction of these hazardous materials. In addition, it has been proposed that e-waste (collection of electronic waste) be included in the program for 2006.

Residents from participating communities will have the opportunity to schedule appointments to drop off household hazardous waste at two (2) separate events scheduled during 2006. Each community will be billed separately for each event.

The County has reviewed and accepted a bid proposal from Small Quantity Specialists (SQS). Communities are now being requested to consider a commitment to this agreement.
