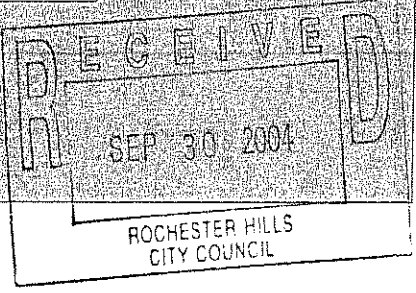

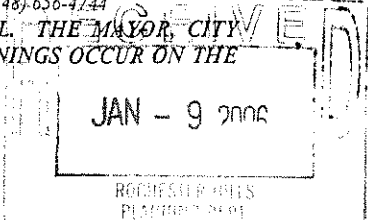

Mr. Turnbull is an experienced Civil/Environmental Engineer who has been extensively involved in CERCLA, RCRA, and TSCA waste management activities. His specific areas of focus include waste disposal facility management, remediation contracting, environmental permit preparation and development, and regulatory compliance and management.

EXPERIENCE

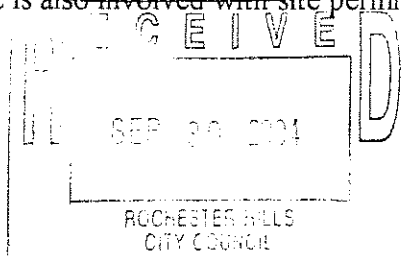
Mr. Turnbull joined City Management Corporation in 1987 as a Manager of Operations for the Environmental Remediation Contracting Division. As Manager of Operations/Vice President of City Environmental Contracting, he was responsible for client development and contract management, coordination of field efforts, and regulatory compliance during project performance.

In 1990, Mr. Turnbull joined the Environmental Engineering Department of City Management Corporation. He was responsible for the environmental regulatory activities for the five RCRA, TSDFs of City Management's Waste Management Group. His activities included permit preparation (non-hazardous and hazardous solid waste, air and wastewater) and development with facility operations staff and consultants as well as implementation of facility upgrades. Other activities included environmental site assessment, environmental TSDF auditing, OSHA and RCRA training and contingency plan preparation.

In 1992, Mr. Turnbull became the General Manager of the Ford Allen Park Clay Mine Landfill (APCML). He was responsible for the on-site management/operation of Ford Motor Company's industrial waste landfill in Allen Park, Michigan. As City Management Corporation's representative to Ford, he was responsible for ensuring all waste streams were handled in accordance with applicable licenses; federal, state, and local rules/regulations; and all Ford issued bulletins/procedures/requirements. Mr. Turnbull was also responsible for all waste disposal activities within the active cell.

In 1993, Mr. Turnbull rejoined the Environmental Remediation Contracting Division of City Management Corporation. As Manager of Remedial Action Services, he was responsible for the direction of, as well as day to day operation of City Environmental Contracting and the Remedial Action Services Division of affiliate company, Inland Waters Pollution Control, Inc.

In 1998, Mr. Turnbull joined Trident Properties, the real estate development division of Soave Enterprises. As Vice President of Trident Properties, he is responsible for land acquisition activities, including site selection and due diligence. He is also involved with site permitting, site development and construction.

Remediation Contracting

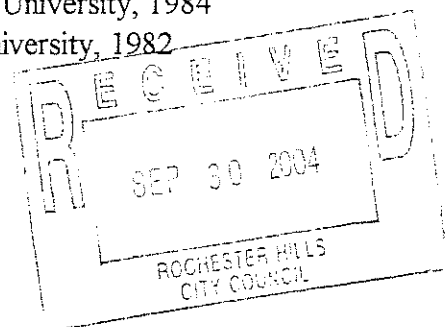
Mr. Turnbull's training and experience in civil/environmental engineering provides him with the ability to address the application of alternative technologies for the remediation of industrial/hazardous waste sites. He was involved in a variety of projects, most notably the Jefferson/Connor Industrial Revitalization Project, Detroit, Michigan, and the Hyatt/Clark Decommissioning Project, Clark, New Jersey. Other projects include the Ford Motor Company Plastics Plant Lagoon Closure, Sandusky, Ohio; the Ford Motor Company Climate Control Plant Remediation, Green Island, New York; and the Parke-Davis Tank Farm Removal, Rochester, Michigan, as well as several underground storage tank removal projects and investigation and remediation of hazardous waste sites.

Prior to joining City Management Corporation, Mr. Turnbull was an Environmental Engineer with the Michigan Department of Natural Resources (MDNR), Environmental Response and Groundwater Quality Divisions. His responsibilities included initiating and completing remedial actions under the Michigan Environmental Response Act. Mr. Turnbull acted as on-scene coordinator and oversaw all aspects of the remedial action at a site, from public relations to contract negotiations to actual clean-up and/or construction activities.

With the MDNR, Mr. Turnbull was also involved in groundwater compliance activities. He was involved in the interpretation and application of water quality principles and practices relative to facilities and groundwater discharges regulated under Michigan Solid Waste Management, Water Resource Commission, and Governing Waterworks and Sewerage Systems Acts.
