RE: Annual Liquor Inspections

Chapter 6, Alcoholic Liquor of the Rochester Hills Code of Ordinances directs an annual inspection of all Class C licensed establishments. These inspections are conducted by the Building Department and reported to the Administration and Information Services Committee. The committee reports its findings to City Council, and council can receive and file the report or call for a public hearing for violators based on information provided in the report.

The Building Department has conducted its inspections and has prepared its report (attached). At this time, all Class C licensed establishments are in compliance as of their inspections with the exception of Pizzapapalis. They have contacted the Clerk's Office to advise that their repairs will be completed by February 15. We will track and verify for AIS at the March meeting. We received a call from the Health Dept. on 2/3/06 advising they would be bringing their reports that will be available at the meeting on 2/7/06.

It does not appear that any of the Class C license holders will be in violation or require any hearings for 2006. Attached is a complete listing of licenses issued in Rochester Hills. You will note several have been transferred out of the city. These licenses are still counted with the Rochester Hills quota of 46 licenses.
