SUBJECT: Cold-Plastic (Pavement Legend) Program “2009” – City File #E09-043

REQUEST:

City Council is requested to authorize the award of the contract for “2009” Cold-Plastic (Pavement Legend) Program to R.S. Contracting, Inc., Casco, Michigan in the amount of \$33,333.83 with a 10% contingency of \$3,333.38 for a total not-to-exceed amount of \$36,667.21.

REASON FOR PURCHASE:

The Road Commission for Oakland County (RCOC) recently received bids for their “2009” County-Wide Cold-Plastic (Pavement Legend) contract. R.S. Contracting, Inc. was awarded the RCOC contract, as the lowest, responsive, responsible bidder. R.S. Contracting, Inc. has agreed to extend the RCOC pricing to the City of Rochester Hills for the “2009” construction season.

The 2009 pavement legend program consists of removal and replacement of pavement legends including “Left and Right-turn” arrows, “Stop Bars”, “X-Walks”, “SCHOOL” and “ONLY” symbols, etc. The proposed pavement markings to be removed and replaced are based upon the 2009 condition inspections performed by City staff. A listing of the 2009 inventory of pavement markings in poor condition is attached for reference.

All replacement pavement legends conform with RCOC’s recently awarded contract that was procured through a competitively bid process. Additionally, all legends materials are 3M Stamark Pavement Marking Tape Series 270 ES with application methods meeting 3M product manufacturers’ guideline and Michigan Department of Transportation (MDOT) specifications.
