SUBJECT: "2006" Local Street Concrete Slab Replacement Program - City File #E06-014

REQUEST:

The Department of Public Service is requesting that City Council approve an amendment to the existing contract for "2006" Local Street Concrete Slab Replacement Program between DiLisio Contracting, Inc of Clinton Township, Michigan and the City of Rochester Hills in the amount of \$54,012.16 (\$5,194.00 balance on current blanket purchase order) for a new not-to-exceed total of \$1,224,427.78.

REASON FOR PURCHASE:

At the September 20, 2006 meeting, City Council approved entering into a contract with DiLisio Contracting for contractor services in the amount of \$1,064,014.20 for the 2006 Local Street Concrete Slab Replacement Program with a 10% contingency of \$106,401.42 for a total amount of \$1,170,415.62.

During the course of the programmed concrete and removal & replacement work, an approximately 1,200 lineal foot segment of Whitney Drive located with Heatherwood Subdivision – City Section 14, failed and needed to be repaired immediately. The emergency repair work at this location amounted to \$184,266.30, thus utilizing all of the contingency monies in addition to a portion of the regularly programmed repair work.

BUDGET:

The project costs associated with the "2006" Local Street Concrete Slab Replacement Program were originally identified in the 2006 2nd Quarter Budget Amendment. The additional \$54,012.16 for the amended contract with DiLisio Contracting, Inc is anticipated to be taken from the remaining available 2008 budget, approximately \$60,000, from the "2008" Local Street Concrete Slab Replacement Program. A 4th quarter budget amendment will be proposed.

The Department of Public Service staff provided all the professional construction engineering services for this project, which included inspection, complaint resolution and contract administration. The City's outside consultant provided Geotechnical services.
