Resolved, that the Rochester Hills City Council hereby approves a purchase order for nine (9) new vehicles. One (1) Chevrolet Malibu Sedan to Buff Whelan Chevrolet, Sterling Heights, Michigan, in the amount of \$12,103.54; and two (2) GMC cargo vans and one (1) GMC pickup be purchased from Red Holman Pontiac GMC Toyota, Westland, Michigan, in the amount of \$43,503.00, utilizing the Oakland County Cooperative Purchasing Program.

It is further recommended that the purchase of three (3) Jeep Liberty's be purchase from Signature Ford/Jeep, Owosso, Michigan, in the amount of \$54,617.13; and two (2) Dodge Dakota pickup's be purchased from Bill Snethkamp's Lansing Dodge, Inc., Lansing, Michigan, in the amount of \$30,268.34, utilizing the State of Michigan's MiDeal Extended Purchasing Program.
