**SUBJECT:** Transfer of Class C License – 2086/2210 Crooks Rd.

**REQUEST:**

To review and make recommendation to City Council for transfer of the Class C License located at 2086/2210 Crooks Rd. The request for transfer is from Baez Enterprises, Inc to transfer the license from HR Restaurants, LLC. The license also includes a Dance-Entertainment Permit. The business is currently in operation as Toscani Grill. The new business will be known as Taco Loco Cantina and Grill.

**BACKGROUND:**

Baez Enterprises, Inc. has submitted its application fees, floor plans, etc. as required by Chapter 6, Alcoholic Liquor of the Rochester Hills Code of Ordinances to request the approval of the Rochester Hills City Council for the transfer. The applicant has also signed the Entertainment Agreement as required by the ordinance. The applicant currently operates an establishment in Shelby Township that is also known as Taco Loco.

The applicant has not proposed any physical changes; they will be completing a cleaning and expect to make some cosmetic changes. They will be applying for their sign permit and will not receive an OK until they have completed inspections. The current business did pass its inspections for the Annual License Review in December 2005. The Fire Department has provided its report. The Building Department and Sheriff Department have not submitted anything in writing as yet.
