SUBJECT: Purchase of Citywide Janitorial Products

REQUEST:

City Council is requested to authorize the purchase of citywide janitorial products, chemicals and cleaning equipment and supplies utilizing the Oakland County Cooperative Purchasing Program to Industrial Cleaning Supply of Waterford, Michigan, for a blanket purchase order in the total amount not-to-exceed Thirty Four Thousand Nine Hundred (\$34,900) Dollars for a term to expire on June 30, 2007.

REASON FOR PURCHASE:

The City of Rochester Hills requires the purchase of paper products, chemical cleaning supplies, cleaning equipment and other items associated with janitorial maintenance that must be delivered to six (6) different locations throughout the City minimally once per month and/or on an as-needed basis. The City's existing contract expires in May. It is recommended that the City of Rochester Hills utilize the Oakland County Cooperative Purchasing Program as it offers substantially discounted prices for the City's core items lower than list, in addition to a percentage discount off catalog prices for those items that may be purchased infrequently. A review of the other cooperative contracts has been done with ICS providing services and products that best meet the City's needs. Industrial Cleaning Supply is able to provide the City with its approved chemicals and cleaning equipment and supplies that have proven to best meet the needs of the City. There are no minimum dollar amounts and no minimum quantities are required. Several other Oakland County cities and townships have also taken advantage of purchasing off the Oakland County Bid. Additionally, Industrial Cleaning Supply is able to provide the City with a number of computer-generated reports. Detailed reports will identify usage, buying habits and purchases by location, all of which will be valuable analysis tools to identify spending habits and product utilization.
