Approval of Traffic Control Order SS-135 Passive stop to Traceky) for Streets within Clear Creek Subdivision No. 3 & 4 - Section #2

**Whereas**, Traffic Control Orders No. SS-135 have been issued by the Transportation Engineer under the provisions of Chapter VI of Act No. 300, Public Acts of Michigan of 1949, as amended (Michigan Vehicle Code), and under the provisions of the City of Rochester Hills Code of Ordinances, Chapter 98 (Rochester Hills Traffic Code), as amended; and

Whereas, said Traffic Control Orders cover:

#### **SS-135.1 Passive Stop to Traceky**

**Whereas**, said Traffic Control Orders shall not be effective after the expiration of ninety (90) days from the date of issuance, except upon approval by this Council; and

**Whereas**, the Advisory Traffic and Safety Board has considered the issues pertaining to the Traffic

Control Orders,

***Resolved***, that the Rochester Hills City Council approves the issuance of Traffic Control Order No. SS-135 to be in effect until rescinded or superseded by subsequent order; and a certified copy of this Resolution be filed together with the Traffic Control Order, with the Clerk of Rochester Hills, Oakland County, Michigan.
