SUBJECT:	Rock Salt

REQUEST:

City Council is requested to approve a blanket purchase order to Detroit Salt, Detroit Michigan for the purchase of rock salt for the winter season 2006-2007 in the amount not-to-exceed \$153,615.00 through June 30, 2007, as primary vendor and North American Salt Company, Overland Park, Kansas, as secondary vendor.

REASON FOR PURCHASE:

Sealed bids were solicited for sodium chloride (rock salt) by the Road Commission for Oakland County on behalf of the Michigan Intergovernmental Trade Network (MITN) with three responding bids. As a cooperative bid 153,700 tons of salt for 17 governmental entities was bid, of which 5500 tons is Rochester Hills.

The specifications require the vendor to provide rock salt for ice control as ordered from August 1, 2006 through June 30, 2007. Each agency has reviewed the bid results and elected to recommend the award to their various councils or boards.

The lowest responsive responsible bidder was Detroit Salt, Detroit, Michigan, at a bid price of \$26.38 per ton. North American Salt Company, Overland Park, Kansas, was the second lowest bid at \$32.58 per ton. As in past years, the secondary vendor will receive twenty-five (25%) percent of the total orders, providing back-up in the event salt quantities become unavailable from the primary vendor.

Funds for bulk rock salt are budgeted in major and local roads. Funds will be proposed in the 2007 budget for rock salt.
