SUBJECT: Field Lighting Borden Park

REQUEST:

City Council is requested to authorize the complete lamp replacement and additional parts, including ballast, capacitors, fuses and lenses, as needed from Musco Sports Lighting, Incorporated in the amount not-to-exceed \$31,944.00.

REASON FOR PURCHASE:

Request for Proposals were solicited for the replacement of bulbs and other parts for the field lighting at Borden Park baseball fields, basketball courts, batting cages and soccer fields. Proposals were evaluated and Musco was chosen as the lowest responsive, responsible proposer.

The field lighting at Borden Park was originally installed in 1991. Currently a number of bulbs are out which affects the playability and safety of the fields. The bulbs have a life expectancy of ten-years and, at fifteen years, have long outlasted their expectant life. Musco proposes a total re-lamp of the facility in its base bid of \$23,144. It is unknown at this time the exact number of replacement parts required. The amount of \$8,800 is being allocated for additional parts, as it is cost effective to replace parts while the large equipment needed for the job is on site.

Based on the age of the lights (fifteen years) and the life expectancy of the ballasts and capacitors (twenty-five years) it is reasonable to anticipate failures of both items within the next ten years.

Musco has been in business for over thirty years and is the manufacturer of the field lights currently installed at Borden Park.
