SUBJECT: "2008" Local Street Concrete Slab Replacement Program

[Hamlin Road Addition - Tri-Party] - City File #E08-001 / E08-021

REQUEST:

The Department of Public Service recommends accepting the unit prices for the proposed additional work to be added to the existing "2008" Local Street Concrete Slab Replacement Program contract with Six-S, Inc. of Waterford, Michigan in the amount of \$203,741.74 and authorize the Mayor and Clerk to execute a contract on behalf of the City. The additional work includes the concrete pavement removal and replacement of approximately 850 feet of EB Hamlin Road from "Old Adams Court" to 750 feet east of Old Adams Road, including a portion of "Old Adams Court" and several "flags" along WB Hamlin Road.

The Department of Public Service also requests City Council authorization of a 10% contingency in the amount of \$20,374.18 to allow for quantity adjustments based on final measurements verified in the field.

REASON FOR PURCHASE:

The City requested that the existing unit prices previously awarded be held for the additional similar items work since it is consistent with the existing project scope (see attached correspondence from Six-S). Please note that an additional pro-rata L. Sum cost for Traffic & Maintenance Control and equipment Mobilization is also included along with several new pay items.

The Scope of Work includes concrete curb & gutter removal and replacement; placement of aggregate base (asdir-by-the-eng), concrete pavement removal and replacement (9" depth); restoration; traffic maintenance and control, and other miscellaneous items of work.

BUDGET:

The project is funded in the 2008 2nd Quarter Budget Amendment under Major Road MR-03 [Concrete Slab Replacement] - \$250,000.00. The Major Road total is \$224,115.92 [\$203,741.74 plus a 10% contingency of \$20,374.18].

Two-thirds of the costs will be reimbursed through Road Commission for Oakland County (RCOC) Tri-Party Program.

RECOMMENDATION:

It is recommended that City Council increase the existing "2008" Local Street Concrete Slab Replacement Program contract with Six-S, Inc. of Waterford, Michigan in the amount of \$203,741.74 and authorize the Mayor and Clerk to execute a contract on behalf of the City.

The Department of Public Service also requests City Council authorization of a 10% contingency in the amount of \$20,374.18 to allow for quantity adjustments based on final measurements verified in the field.

The Department of Public Service staff will provide the following construction professional engineering services for this project including: inspection, complaint resolution, and contract administration, which will be charged to the project, along with outside consulting services for geotechnical materials testing.
