**SUBJECT:** Unleaded Gasoline and Diesel Fuel

### **REQUEST:**

City Council is requested to authorize the purchase of unleaded fuel and diesel to Petroleum Traders Corporation, Fort Wayne, IN and RKA Petroleum Companies, Inc., Romulus, Michigan in the amount not-to exceed \$688,500.00 through January 31, 2013.

### **REASON FOR PURCHASE:**

The City participates with the Michigan Intergovernmental Trade Network (MITN) for the purchase of unleaded fuel and diesel. Based on bids received on November 1, 2011, by the City of Sterling Heights, the lead city on behalf of the cooperative, Petroleum Traders, Inc. (unleaded fuel) and RKA Petroleum Companies, Inc. (diesel) received the split award of the contract as lowest, responsive and responsible bidders for truck transport deliveries.

Cost for gasoline and diesel are calculated based on the Oil Price Information Service (OPIS) Daily Average for the Detroit area, plus the vendor's bid factor (delivery fee) per gallon. Below is a breakdown of pricing per gallon for truck transport deliveries of fuel. Wholesale pricing was based on the OPIS Detroit Rack Average on November 22, 2011:

By awarding to the two low bidders, the City has the ability to leverage favorable pricing based upon the type and quantity of fuel purchased. It also provides the City with a secondary source of fuel in the event of an emergency. RKA has provided good performance in prior contracts and Petroleum Traders is the largest independent distributor of gasoline and diesel fuel in the country, utilizing local vendors, as RKA and Atlas.

Prices charged to MITN members through the cooperative bid will fluctuate based on market conditions, but are considerably lower than the consumer pump prices. Qualifying governmental entities are tax exempt, however, certain state and federal fees are payable at approximately \$0.01165 per gallon.

As the result of the competitive bid processes the regular unleaded gasoline factor of \$0.0078 is 66% lower than the incumbent vendor and ULS Premium Diesel #2 factor is 49% lower.

The City uses approximately 55,000 of unleaded gasoline and 60,000 gallons of diesel annually. The cooperative purchases approximately 3,000,000 gallons of gasoline and 1,000,000 gallons of diesel fuel annually.

The bid also includes optional pricing for biodiesel. Although municipal demand for these alternative fuels is presently low, it is anticipated that market conditions may result in a greater demand in the future.
