### Text of Legislative File 2006-0272

..Title

Approval of Traffic Control Order PK-89 - No parking within the right-of way on both sides of Yorktowne Drive from Rochester Road to Grosvenor Drive

..Body

**Whereas**, Traffic Control Order No. PK-89 has been issued by the Transportation Engineer under the provisions of the Rochester Hills Code of Ordinances, Chapter 98, Michigan Vehicle Code, MCL 257.1 et seq.; and

**Whereas**, said Traffic Control Order covers:

**PK-89 No Parking within the right-of-way on both sides of Yorktowne Drive from Rochester Road to Grosvenor Drive.**

**Whereas**, said Traffic Control Order shall not be effective after the expiration of ninety (90) days from the date of issuance, except upon approval by this Council; and

**Whereas**, the Advisory Traffic and Safety Board has considered the issues pertaining to the Traffic Control Order and recommends that the Order be approved.

**Resolved** that the Rochester Hills City Council approves the issuance of Traffic Control Order PK-89 to be in effect until rescinded or superseded by subsequent order; and

**Now, Therefore, Be It Resolved** that a certified copy of this Resolution be filed together with the Traffic Control Order, with the City Clerk of Rochester Hills, Oakland County, Michigan.
