REQUEST:

The Department of Public Service recommends accepting the bid and awarding a contract for the Avon Intersection Improvements at Livernois & Rochester Roads and Butler Road Improvements Project to Cadillac Asphalt of Clarkston, Michigan as the lowest responsive, responsible bidder in the amount of \$383,661.24 and authorize the Mayor and Clerk to execute a contract on behalf of the City.

REASON FOR PURCHASE:

On Thursday, May 25, 2006, the City received three (3) sealed bids for the Avon Intersection Improvements at Livernois & Rochester Roads and Butler Road Improvements Project and Cadillac Asphalt was the lowest responsive, responsible bidder. The bid received from Cadillac Asphalt is 3% over the Engineer's Estimate and 3% below the next lowest bidder, Peake Contracting, and 11% lower than the highest bidder, Six-S, Inc., which is shown on the attached bid tabulation. Work is expected to begin in July 2006 with a completion date scheduled for September, 2006.

The Scope of Work for this project includes the following:

- 1. Butler Road Improvements include removing the existing landscaped traffic island located at west city limits and replacing with two through lanes of pavement, which consists of the removal & replacement of existing pavement and curb & gutter; installation of under drains; placement of aggregate base; restoration.
- 2. Avon Intersection Improvements at Livernois Road include extending the existing center leftturn land and the existing right-turn lane along the west leg of the intersection, which consists of the installation of storm sewer; pavement widening; curb & gutter installation; installation of under drains; placement of aggregate base; restoration.
- 3. Avon Intersection Improvements at Rochester Road include extending the existing right-turn lane along the east leg of the intersection, which consists of the installation of storm sewer; pavement widening; curb & gutter installation; installation of under drains; placement of aggregate base; restoration.

BUDGET:

Costs associated with this 2005 Capital Improvement Project were carried over to the 2006 Capital Improvement Plan (CIP) in a 2nd quarter budget amendments and were identified as MR-49A Avon Rd @ Livernois Intersection, MR-49B Avon Rd @ Rochester Intersection and as MR-15B Butler Road Improvements.

The City will be responsible for budgeting the entire project amount for the Avon Rd intersections up front with two-thirds reimbursement of the final cost forthcoming via the 2005 Tri-Party Program Agreement. Butler Rd Road Improvements is 100% City cost.
