## SPECIAL ANNOUNCEMENT

President Rosen made the following announcement:

Rochester Hills Mayor Pat Somerville will be absent for a time and has asked City Council President James Rosen to serve in the capacity as Mayor Pro Tempore during her absence.

## **PUBLIC COMMENT**

**Ms. Nancy Raffler**, 713 West Auburn Road, questioned whether the Mayor's previous absences violated the City's Charter. She thanked Mr. Ambrozaitis for addressing the issue and the matter of the General Fund supporting essential services, stating, "We need Council members with the courage to look into different ways of doing things."

**Mr. Lee Zendel**, 1575 Dutton Road, questioned the legality of consolidating millages. He noted that even if they were consolidated the City still needs four to five million dollars annually to properly maintain local roads, with an additional four to five million dollars for street reconstruction.

**Mr. Matthew Bruno**, 3475 Longview Avenue, noted that poorly maintained homes in his subdivision are having a detrimental effect on property values and asked for assistance with this issue.

Ms. Deanna Hilbert, 3234 Quail Ridge Circle, indicated her support for Mr. Ambrozaitis, stating, "I'm glad that he's serving the City."

Mr. Bill Windscheif, 2872 River Trail, praised the Council members, noting his belief that "each and every member gets up every morning and wants to do the right thing for the City." However, he noted that personal rhetoric and attacks had become apparent since the new Council was seated and expressed his hope that this would end.

*Mr. Paul Miller*, 1021 Harding Avenue, expressed his belief that Council needs to explore new ideas for solving the City's problems.

**Ms. Lois Golden**, 645 Apple Hill, praised Mr. Ambrozaitis for "thinking like a taxpayer" and urged Council members and audience members to treat one another with dignity and respect.

## **LEGISLATIVE & ADMINISTRATIVE COMMENTS**

Council members wished Mayor Somerville a speedy recovery.

**Ms. Raschke** noted that she had received letters from local high school students regarding a traffic issue and assured them their concerns would be addressed by City staff in a timely manner.

**Ms. Holder**, addressing Mr. Bruno, urged him to contact the City's Ordinance Enforcement officers and noted that residents can contact their Council members with these issues.

*Mr. Duistermars* noted that the City is following the Charter by appointing President Rosen Mayor Pro Tempore in the Mayor's absence.

**Mr. Ambrozaitis** indicated that he had forwarded information about Mr. Bruno's complaints to the City Attorney and asked that the City consider a comprehensive blight ordinance.

Mr. Barnett urged Mr. Bruno to speak to Scott Cope, the City's Director of Building and Ordinance Enforcement. He also praised the Rochester Hills Government Youth Council for their recent successful voter registration drive held at Rochester and Adams High Schools. He then announced that the Velodrome at Bloomer Park had recently been awarded the Daniel L. Flaherty Memorial Award.

## **ATTORNEY MATTERS**

**City Attorney John Staran** indicated he would work with Mr. Cope to address the blight matter, and assured Council and residents that he was working with President Rosen to ensure that the various steps and protocols are followed concerning the Mayor Pro Tempore situation.

- 4. The City Treasurer shall provide annually a written report to the City of Rochester Hills City Council concerning the investments of the funds.
- 5. The City Treasurer is authorized to rely on the continuing effect of this resolution until and unless it is specifically amended or rescinded by a future resolution of the City of Rochester Hills City Council.
- 6. This resolution supersedes all previous resolutions, parts of resolutions, and City of Rochester Hills City Council policies inconsistent with this resolution or with State law, and this resolution will take effect immediately.

**Mr. Roger Moore**, Professional Surveyor, explained that the addition of an article to the Utilities Ordinance to prohibit illicit discharge will bring the City into compliance with the Michigan Department of Environmental Quality's (MDEQ) General Storm Water Permit.

**Mr. Yalamanchi** expressed concern that residents would be dealt with harshly for such minor infractions such as washing their cars in their driveways.

**Mr. Moore** and **City Attorney John Staran** assured Council that the City's primary concern was to address major polluters and to educate private residents as to the proper disposal of waste waters and other polluting substances, rather than to fine or imprison them.

## **NEW BUSINESS**

#### 2005-0366

Approval of Preliminary Site Condominium Plan - City File No. 05-005 - Pine Woods Condominiums, a proposed 29-unit site condominium development on 9.5 acres, located south of Auburn, west of M-59, zoned R-4, One Family Residential, Parcel Nos. 15-34-101-012 & -013, Lorenzo Randazzo, applicant

*Mr. Lorenzo Randazzo*, applicant, L&R Homes, 2490 Walton Boulevard; *Mr. Ed Anzek*, Director of Planning/Development; and *Mr. Paul Shumejko*, Transportation Engineer, described the proposed preliminary site condominium plan noting specifically:

- Although the proposed subdivision road was originally anticipated to connect to Auburn Road, MDOT and the City's engineering staff determined that the road would be in too close a proximity to the crest in the bridge overpass over M-59 and, thus, unsafe.
- Mr. Randazzo has been in negotiations with the neighboring Hazelwood condominium subdivision to provide road connectivity to Grand Park.
- In addition to approving the preliminary site condominium plan, the Planning Commission approved a waiver for a temporary cul-de-sac to be built until the development is built out to the point where the cul-de-sac can be opened to connect to Livernois.
- There are two parcels of property that Mr. Randazzo is in negotiations to purchase that would allow the cul-de-sac to be completed and connect to Livernois.
- The proposed 29 condominium units on 9.5 acres of land equates to a density of

3.04 units; this is well within the density of 3.4 units for the development's R-4 zoning classification.

 As the planned detention pond is a dry system, it can double as open space for the proposed condominium development.

## **PUBLIC COMMENT**:

Mr. Joe Anderson, 3032 Grand Park, a resident of the Hazelwood subdivision, questioned whether a conservation easement could be put in place to protect the trees along the common border between his subdivision and the proposed new development. He also asked for clarification as to the standards for the detention basin. He noted it was sized for a ten-year storm event and it was his understanding that Oakland County now requires a 100-year storm event standard.

Ms. Samantha Phillips, 3220 Grand Park, asked what remedy the City was proposing for the doubling of proposed vehicle trips per day for the single entrance on Grand Park Boulevard. She further expressed her concern about the density of the new development and the likelihood that children from the proposed Pine Woods Condominiums would enter the Hazelwood subdivision and utilize their open space. She noted that the Planning Commission had discouraged the idea of the two subdivisions forming a single neighborhood association.

Mr. Ronald Rader, 3009 Grand Park, noted his concern for the children of the new subdivision, as the school bus does not travel through the subdivision for pickup, but rather stops on Hazelton Avenue only. He noted some children at the back of the new development may have to walk as far as a mile to reach the bus stop.

Mr. William Bell, Jr., 3201 Grand Park, expressed his concern that the new detention pond could result in flooding in his yard and basement.

Mr. Anzek, Mr. Randazzo, and Mr. Shumejko addressed the questions raised by residents:

- A conservation easement included in the master deeds and bylaws is a possibility, however, the City would not be responsible for enforcing it.
- Oakland County only requires a 100-year storm event standard if the basin ties into the Oakland County drain system.
- It is the developer's intention to secure property that would allow access directly to Livernois, thus alleviating additional traffic on Grand Park Boulevard.
- The Avondale School District sets their student pickup schedules and locations and has reduced the pickups based on financial concerns.
- Flooding is a possibility in the case of a severe storm, however, the detention basin is a dry system and is not designed to hold water for more than a day.
- During construction the Oakland County Drain Commission (OCDC) requires sediment devices at sewer inlets and outlets often resulting in flooding during the construction process.
- It is likely MDOT will approve temporary access off of Auburn Road for construction traffic only.

#### **COUNCIL DISCUSSION:**

Mr. Anzek, Mr. Randazzo, Mr. Shumejko and City Attorney John Staran addressed questions and concerns raised by City Council members:

- Combining homeowners associations would require the assistance of a condominium attorney.
- Mr. Randazzo would retain control over the association until the development is nearly complete.
- The acquisition of Lots 6 and 7 to be used to link the new road to Livernois meets all of the City's standards and requirements.
- The drainage problems associated with the nearby mosque that were experienced by area homeowners will likely be resoled by this proposed development.
- Road access through the Hazelwood subdivision will require the purchase of a "sliver of land" under private ownership.
- The detention pond cannot be moved closer to the retention pond as the water would then have to move up hill. The current position is in the lowest area of the development where water will flow naturally.
- The price points of the homes will be approximately \$400,000 to \$450,000.

A motion was made by Duistermars, seconded by Raschke, that this matter be Adopted by Resolution.

Resolved that the Rochester Hills City Council hereby approves the Preliminary Site Condominium Plan for Pine Woods Site Condominiums (City File No. 05-005), based on the plans dated received by the Department of Planning and Development on January 23, 2006, with the following findings and subject to the following conditions. The affected property is zoned R-4, One-Family Residential and identified as Parcel Nos. 15-34-101-012 & -013; Lorenzo Randazzo, L & R Homes, Inc., applicant.

## Findings:

- 1. Upon compliance with the following conditions, the preliminary plan meets all applicable requirements of the Zoning Ordinance and One-Family Residential Detached Condominiums Ordinance.
- 2. Adequate utilities are available to properly service the proposed development.
- 3. The preliminary plan represents an acceptable comprehensive development plan.
- 4. The preliminary plan represents a reasonable street layout and lot orientation.
- The Environmental Impact Statement shows that this development will have no substantially harmful effects on the environment.

#### **Conditions:**

- 1. Indicate proposed lighting, including street lighting, or note there will be none.
- 2. Add note to the plan that all proposed signage will conform to the City's Sign Ordinance and that a sign permit will be required prior to installation.
- 3. That the applicant incorporate a 15-foot landscape strip along Auburn Road to

buffer the homes on the north end of the development, as approved by the City's Landscape Architect prior to final site condominium approval.

- 4. Correct Sheet 7 of 7 to show revisions as outlined in memo from the City's Landscape Architect dated November 15, 2005.
- 5. Tree Protective Fencing must be installed, inspected and approved by the City's Landscape Architect prior to issuance of a Land Improvement Permit.
- All construction traffic shall enter from a temporary construction road off of Auburn Road.
- Construction of Lot 17 shall be postponed until the connection to Livernois is made for future development.
- 8. Detention pond screening shall be added, as reviewed and approved by Staff.

Mr. Mike Hartner, Director of Parks & Forestry, clarified that the donation offer from Mr. Anthony Lombardo was separate from the \$368,000 paid as part of the Nowicki Park land swap arrangement. He noted that Mr. Lombardo requested that the use of the donated monies be restricted to the development of Nowicki Park.

**Mr. Yalamanchi** expressed his desire that the donated funds be used exclusively to pay for the design plans for the development of Nowicki Park.

Mr. Ambrozaitis questioned how this donation arrangement "evolved."

**Mr. Hartner** explained that Mr. Lombardo made the verbal offer during a meeting regarding the Parks and Recreation Master Plan approximately three months previous.

A motion was made by Barnett, seconded by Yalamanchi, that this matter be Adopted by Resolution.

Whereas, Lombardo Company has offered to donate to the City of Rochester Hills \$1,000 for each of the proposed 58 condominiums that will be built on the Meadowfield Drive property as they are sold; and
