Mr. Noe Baiz, 11738 Hiawatha, Shelby Township, applicant, was present to answer questions.

Ms. Holder briefly explained that the proposed Taco Loco restaurant would be replacing the Toscani Grille at Crooks Road and M-59. She noted that Mr. Baiz, during a recent Administration & Information Services Committee meeting, had offered "some good perspective" on why other restaurants had failed in that same location and why he felt his restaurant would succeed. She also noted that Mr. Baiz operates a successful Taco Loco restaurant at Van Dyke and 24 Mile Road.

A motion was made by Raschke, seconded by Holder, that this matter be Adopted by Resolution.

Resolved that the request from Baez Enterprises, Inc. to transfer ownership of a 2005 Class C licensed business with dance entertainment permit agreement, located at 2086 and 2210 Crooks Road, Rochester Hills, Oakland County, Michigan from HR Restaurants, LLC be considered for approval.

Therefore, Be It Resolved, that the Rochester Hills City Council hereby concurs with the recommendation of the Administration & Information Services Committee to Waive the \$1,000 Special Meeting Fee to be charged to Baez Enterprises, Inc. to consider the transfer of a 2005 Class C License with Dance-Entertainment Permit located at 2086 and 2210 Crooks Road, Rochester Hills, Oakland County, Michigan 48309 from HR Restaurants, LLC.
