SUBJECT: Adams Road Relocation Design Engineering Contract, City File No. E01-004

REQUEST:

City Council is requested to approve a \$50,000.00 increase to the existing Continuing Engineering Design contract for the engineering design and right-of-way document preparation costs associated with the Adams Road relocation project. Approval of this amendment request will finalize and close out the contract with the design engineer consultant.

REASON FOR PURCHASE:

Awarding of the initial Adams Road relocation engineering design contract to Finkbeiner, Pettis & Strout, Inc. (FPS) was made approximately five years ago. During the subsequent design period, several major changes occurred such as: FPS being purchased by a company called Arcadis, key former FPS design and management personnel terminating their employment shortly after the acquisition by Arcadis, the termination of the Adams/M-59 consent judgment by Rochester Hills, and the reinstatement of a consent judgment for the Adams/M-59 area.

The design completion and termination/reinstatement of consent judgments required some work that was outside of the original scope of the engineering design consultant's services. A listing of the additional services is attached. The initial compensation request was higher (approximately \$18,000) but the amount was reduced during subsequent negotiations between the City Engineer and Consultant representatives. The proposed amount of \$50,000 to complete the project is suggested as appropriate for the closing of the project with Arcadis for preliminary and final design, specifications, right-of-way, and bidding assistance items.

BUDGET:

The Local Development Finance Authority Fund has covered design costs associated with the M59/Adams Road relocation project. A budget amendment for the \$50,000 increase was passed by the LDFA at their July 13, 2006 meeting since the amount was not identified in the 2006 budget. The \$50,000 increase was addressed as part of the City's 2nd quarter budget amendments under account #848.970000 and identified as MR-05A/Adams Rd. Relocation (Preliminary Engineering).
