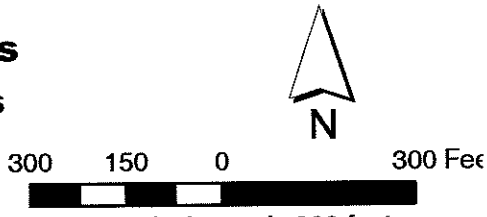


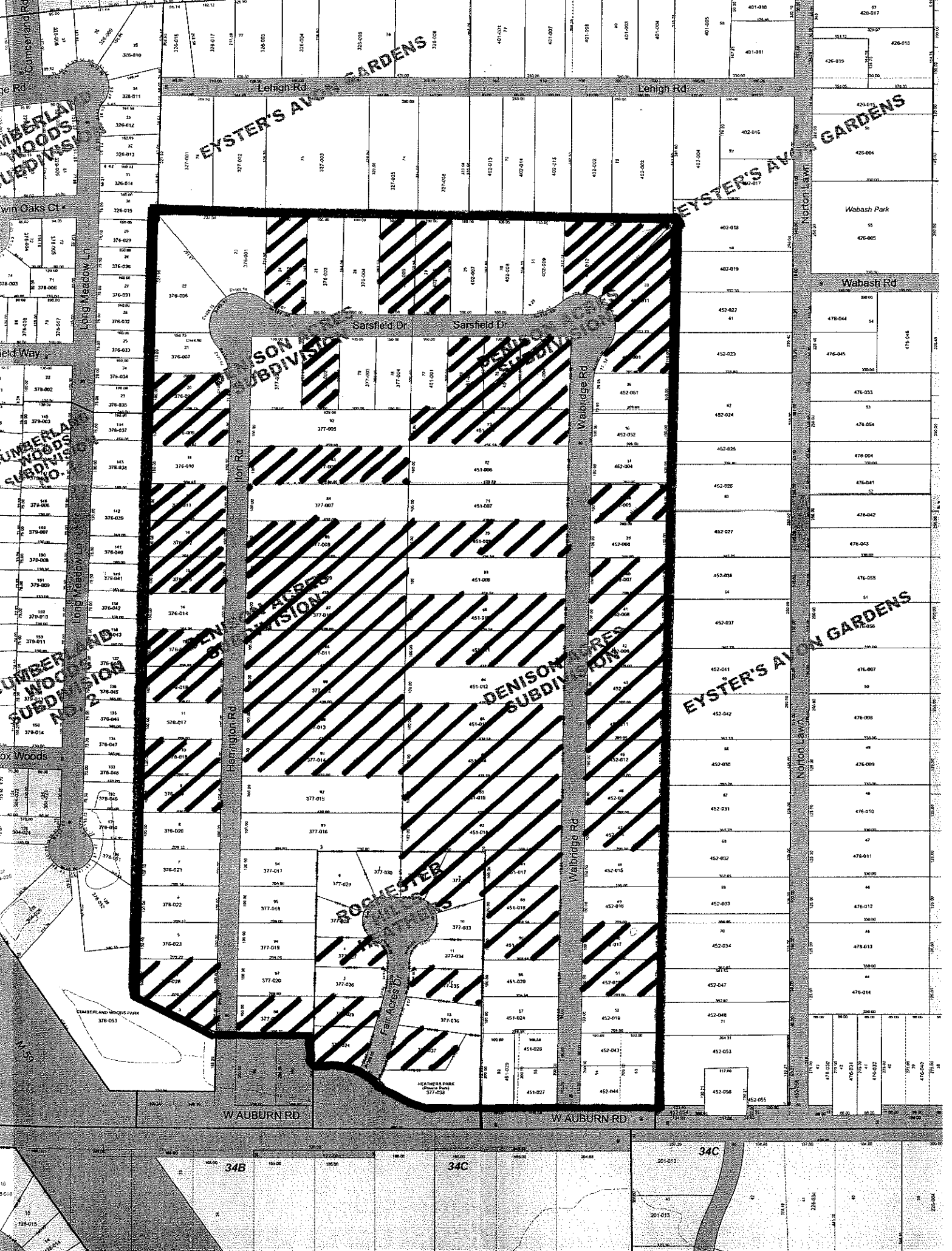


Street lights covered in lighting agreement
