Derek, In reviewing the email sent to you by Bruce Moore to transmit our comments on the draft application for this project, I wanted to clarify that the application was submitted by REI and not the city or the BRA. The DEQ understands that the City and the Brownfield Redevelopment authority (BRA) have not submitted a signed application or agreed to be the applicant for the project yet. We have reviewed and provided our comments on the draft application at the request of REI. Normally we would not review or provide comments on an administratively incomplete application. Normally we would work with the applicant (i.e. the local unit of government or the BRA) to ensure that the submitted application is a final application and would require only one review. You will find attached our review comments regarding the Rochester Hills Brownfield Redevelopment Authorities application for Brownfield Redevelopment grant and loan funding. This application has been assigned a tracking code number of 2006-1071. Please include this tracking code number on all documents and correspondence relating to this application. thank you.

The application was received in this office on August 3, 2006, however, the application package was found to be incomplete. The BRA is interested in receiving an expedited review of this application and for this reason the DEQ has proceeded with a review of this submittal although the package was incomplete.

In a phone call on Friday, 8/11/06, we discussed in general the findings of our review with you. The attached notes provide specific details on what is necessary to provide an administratively complete package, and what is necessary to enable the DEQ to approve your application for funding.
