In accordance with the provisions of Act 267 of the Public Acts of 1976, as amended, the Open Meetings Act, notice was given that a Special Rochester Hills City Council Meeting would be held on Thursday, May 4, 2006, at 7:30 p.m. for the purpose of interviewing candidates to fill the City Council District 3 vacancy and possibly appoint a new District 3 City Council Member, term to expire November 18, 2007.

President Rosen explained the process by which candidates would be interviewed by City Council. He noted that each Council member would ask a question of all candidates. The recording secretary would call each candidates name in a random order. A recess would be taken after the first round of questions and it would then be determined whether a second round would be necessary. He further indicated that following the question and answer process, Council members would nominate one candidate each. Votes would be taken and,

depending on the time, the meeting could be adjourned and a Special Meeting convened on Saturday, May 6, 2006 to proceed with the voting process. He noted that voting would continue until one candidate received a majority of votes.

City Council provided each candidate with an opportunity to introduce themselves and briefly describe their background and interest in serving as a City Council member:

Mr. Clark Barrett, 1696 Dancer Drive, stated that he is an engineer and a Major in the Michigan National Guard, currently completing his dissertation for a Doctor of Philosophy in Leadership. He noted that he has a growing family and is interested in acting locally to their advantage. He indicated that his leadership skills could contribute to the community.

**Ms. Cynthia Billings**, 3092 Avalon, noted she is a five-year resident of the City who volunteers on a regular basis and is an attorney working for a firm in Southfield. Her legal career focuses primarily on municipal retirement systems. She stressed her leadership skills as well as her educational and professional background.

Mr. Terry T. Brown, 1363 Seville Road, indicated he is a forty-year resident of the greater Rochester area with a great deal of experience in the marketing and public relations field. He stressed that he has an "abiding interest in City government" and has no preset agenda that he would bring to the position of City Council member.

**Ms. Danielle deCaussin**, 1855 Meadowvale, noted she is a twenty-year resident of the City with a Bachelor's Degree in Human Resources from Oakland University.

**Mr. Ryan Downs**, 1643 Colony Drive, stated he is a seventeen year resident of the City currently completing a Bachelor's Degree in Political Science at Michigan State University. He indicated his interest in politics and his desire to remain in the community following his graduation.

Mr. Paul Funk, 2176 Rochelle Park, noted he is a twelve-year resident of District 3 who previously served on Council in 1991 and 1992. He stressed his community involvement noting he had "worked with and for almost every community organization in the Rochester Hills area." He indicated that his "wealth of experience" would allow him to step into the position of Council member and "go to work immediately."

**Ms. Julie Granthen**, 1527 Northumberland, indicated she has lived in Rochester Hills for nearly forty years. She noted she is a Professor of Economic and Legal Analysis.

**Mr. Dale Hetrick**, 1586 Deerhurst Lane, explained that he has been a Rochester Hills resident for eleven years and is a local business owner. He noted that his firm works with "businesses to develop the attitudes and behaviors that lead to results."

**Mr. Greg Hooper**, 545 Parkland, noted he currently serves as the Chairperson of the Planning Commission and that he is independent with no ties to any other groups. He praised his fellow candidates for getting involved in their community and encouraged them to continue that involvement.

Mr. Brian Robichaud, 2815 Walsh, stated he has been a citizen of Rochester Hills for five years. He noted that he was asked to apply for this position and that he is often asked to take on roles of leadership. He described his involvement in Boy Scouts and his service in the Navy and assured Council, "I'm willing to step up to the plate and take on this challenge."

Mr. Charles Tischer, 3141 Bathurst Avenue, noted that he is a two-year resident of Rochester Hills who grew up in the area and attended Avondale High School. He explained that he is currently employed by a non-profit organization affiliated with the Republican Party

but would approach his work with the City Council with no agenda. He stressed his experience in the political arena and with budgets and noted that he is a "team player."

Mr. Emmet Yukon, 2260 Warrington Road, stated he is a twenty-four year resident of the City who has seen a great deal of growth and change in the community. He noted he has a Master's degree in Public Relations and has many years experience in the public and non-profit sectors. He has worked with two municipalities as well as the Rochester School District. He stressed that his education and work experience make him uniquely qualified for the appointment to City Council.

President Rosen, noting that the interview portion of the proceedings had been completed, explained that the nomination process would commence and read from the City Council's Rules of Procedure Article IV, Section .02 regarding filling vacancies of Council officers, noting it follows the same procedure as electing officers. He then read from Article IV, Section .01 explaining that each Council member would nominate one candidate, at which time there would be a roll call vote. He indicated that if no nominee received a majority of the votes, nominees with the lowest number of votes would be removed from consideration and voting would continue on the remaining candidates. This process would continue until a single candidate received a majority of votes. President Rosen, acknowledging that the process to this point had been lengthy and tiring, suggested that Council make their nominations and that the meeting be adjourned until the following Saturday, thus giving Council members time to consider the nominees more fully and then continue with the voting at that time.

Council members briefly considered altering the nomination process allowing members to choose three potential nominees, however, the consensus of Council was that that process was more confusing and cumbersome and the original process of one nominee per Council member be attempted first and any alternate plans be considered if there appeared to be a need.

All of the Council members praised the applicants for their willingness to participate in the candidate process and for their thoughtful answers.

**President Rosen** opened the floor for nominations.

President Rosen nominated Mr. Paul Funk.

Ms. Holder nominated Mr. Greg Hooper.

Mr. Ambrozaitis nominated Mr. Emmet Yukon.

Mr. Duistermars nominated Mr. Brian Robichaud.

Ms. Raschke nominated Mr. Terry T. Brown.

Mr. Yalamanchi nominated Mr. Emmet Yukon.

President Rosen closed the floor for further nominations.
