Resolved, that the Rochester Hills City Council approves the Revised Cost Participation Agreement for

Construction of Crooks Road, Square Lake Road to Highway M-59, between the City of Rochester Hills and the Board of Road Commissioners for the County of Oakland and authorizes the Mayor and Clerk to execute the agreement on behalf of the City; and

Further Resolved, that the Rochester Hills City Council authorizes the City's share of the estimated total match, identified in the Revised Cost Participation Agreement, in the amount of \$1,855,100, and any additional cost that accrues through the terms of the agreement, if budgeted.
