Each year in November, RARA reviews its budget to make amendments for the Fiscal Year.

These amendments affect the year-end audit.

This is our last chance to amend the 2010 budget.

By law, we are to spend only budgeted funds. Attention is focused primarily on expenses, as we may bring in more revenues than budgeted without penalty.

Listed below are my recommendations for Revenues and Expenses to be amended.

These amendments do not affect any funds contributed by either Rochester or Rochester Hills.

Last year at this time, we anticipated that we would need to use \$43,500 from the fund balance. It turned out that RARA brought in sufficient revenue by year-end and we did not need to use any fund balance.

For 2010 I am anticipating no need to use the fund balance. The recommendation is to decrease the budgeted amounts to both the revenues and expenses by \$3,150.
