> Request for the Establishment of an Industrial Development District and Declaration of Intent to file Application for Industrial Facilities Exemption Certificate Pursuant Public Act 198 of 1974


## Dear Honorable Council:

We are writing on behalf of the American Axle & Manufacturing, Inc. (hereinafter "AA&M") located at 2965 Technology Drive. AA&M intends to file an Application for Industrial Facilities Exemption Certificate, with the City of Rochester Hills at a later date for eligible property to be installed subsequent to this request for establishment of the Industrial Development District. Establishing the Industrial Development District does not invoke a tax abatement at this stage.

American Axle & Manufacturing, Inc. hereby requests that the City of Rochester Hills establish an Industrial Development District with boundaries, at a minimum, coincident with the portion of real property that is occupied by AA&M. The property for which we are requesting designation by the Council as an Industrial Development District may be referenced by parcel number 70-15-30-477-014.

The property has met the basic conditions required to qualify a parcel for consideration for the establishment of an Industrial Development District, as set forth by Sections 4(1), (2) and (3) of Public Act 198 of 1974, as amended. The details of these conditions are as follows:

- The total ad valorem taxes levied by all taxing authorities on properties within the jurisdiction exceeds \$30.00 for each \$1,000 of state equalized value,
- AA&M owns greater than 75% of the industrial property located within the proposed industrial development district, and
- AA&M has not commenced the physical installation of the property for which they plan to submit an application for certification under Public Act 198 of 1974, as amended.
