SUBJECT: HVAC Contractor Services and Energy Efficient Equipment

#### **REQUEST:**

The Building Department requests approval of the purchase of HVAC/mechanical contractor services and energy efficient equipment for replacement at four (4) City facilities to K & S Ventures, Inc., Auburn Hills, Michigan in the amount of \$54,906.05 with a 10% contingency of \$5,490.61 for a total not-to-exceed amount of \$60,396.66.

### **REASON FOR PURCHASE:**

Recognizing the need to improve energy efficiencies in public buildings, the City included in its submission for American Recovery and Reinvestment Act (ARRA) funds and received EECBG funding approval for HVAC/mechanical upgrades for efficient and increased performance and reduction of energy consumption. The projects included are:

Fire Station #2 Natural gas fired overhead infrared tube heater

Fire Station #4 Natural gas fired multi position furnace/heat pump split system

School House Natural gas fired boiler

Farm House Natural gas fired boiler

Replacement equipment will be energy efficient, meeting the requirements of the Department of Energy and the ARRA guidelines, including Buy American. It is anticipated that the City will achieve energy savings of \$3,406.00 per year.

Request for Proposals were solicited and proposals were evaluated by Ken Nightlinger, Mechanical Inspector/Plan Reviewer, Scott Cope, Director of Building/Facilities Department and Jean Farris, Supervisor of Procurement. K & S Ventures, Inc. was selected as providing the lowest cost and overall best value for the City. K & S Ventures, Inc. has performed satisfactory on-call mechanical work for the City over the past several years. The project must meet the Davis Bacon provisions for labor and other mandated Federal requirements and reporting attached to the ARRA funding.
