SUBJECT: Appointment of City Council Members to Boards & Commissions (19)

Article VII, Section 01(a) - Boards and Commissions of the *City Council Rules of Procedure*, states
“In order to provide a liaison and give the Council representation before various Boards, Commissions and Community-based Groups, the Council shall appoint members at the first meeting each December to serve as a liaison to one (1) or more Community-based Groups, Boards, or Commissions affecting the City.”

Most Boards and Commissions have a one-year term that ends December 12, 2007 or the expiration of the Council member's term of office.
