I would appreciate your consideration in light of my long-standing record of community leadership within the City of Rochester Hills as well as other public service arenas.

While I would be willing to serve on either, my first preference would be to serve on the Police and Road Funding TRC. I believe I have extensive experience and unique qualifications to assist the Police and Road Funding TRC bring a proposal to City Council that can help address this critical component of our local government funding structure.

As you may know, I have enjoyed a long relationship with our great city having served in many capacities. Having served previously on the City Council in 1991-92 as the District 2 Councilman and the Planning Commission from 1990-92 and 1994-96, I had the opportunity to participate in Master Land Use Plans, Road Plans, Master Recreation Plans, Capital Improvement Plans, and have reviewed numerous projects and ordinances. This includes a number of key State and County organizations like the MDEQ/DNR, Oakland County Drain and Road Commissions, MDOT, etc. as well as other organizations that support Rochester Hills like SEMCOG, the Clinton River Watershed Council, etc. I also have had considerable experience in working with the OC Executive, Sheriff, Clerk, Treasurer, Courts and other key organizations.

While I have been chosen to continue making contributions to the GSAB Program in Rochester Hills, I am very impressed with the number of qualified residents that continue to support the GSAB whether or not they have an official seat on the GSAB. While it would be my desire to continue serving on the GSAB as well, I would not want that to preclude my selection to serve on the Police and Road Funding TRC as the TRC assignment is for a defined, short-term timeframe.

Throughout all my professional and community experience, I have been involved in assessing complex processes and problems and have a good sense of how to establish clear, concise recommendations. I have had numerous experiences in defining solutions to complex financial scenarios as well.


