# Text of Legislative File 2009-0411

#### Title

Request for Approval of the HDSC's recommendation to deny eliminating the locally designated historic district at 1585 South Rochester Road, located on the east side of Rochester Road, north of Hamlin Road

### **Body**

**Whereas**, Division 4 of the City's Historic Preservation Ordinance (Chapter 118) establishes the procedure for the establishment, modification or elimination of Historic Districts; and

Whereas, Section 118-130 of the City's Historic Preservation Ordinance (Chapter 118) identifies the duties of

the City's Historic Districts Study Committee and the process for establishment of a study committee report; and

Whereas, the City's duly established Designated Non-Contiguous List included the following property identified as:

1585 S. Rochester Road, located on the east side of Rochester Road, north of Hamlin Road, consisting of Parcel Number 15-23-300-035, Zoned B-2 (General Business) with a PUD overlay; and

Whereas, in compliance with the City's Historic Preservation Ordinance, the City's Historic Districts Study Committee conducted research on the above identified property; prepared a Preliminary Report in November, 2009; transmitted a copy of the Preliminary Report to the City's Planning Commission and the State Historic Preservation Office; held the required and properly noticed Public Hearing on February 11, 2010; and submitted a Final Report to City Council; and

Whereas, the City's Historic Districts Study Committee has determined that the historic district has not lost the physical characteristics that enabled establishment of the district, that the district was not established pursuant to defective procedures, and that the district is significant in a way previously defined;

**Now, Therefore, Be It Resolved,** that the City of Rochester Hills City Council concurs with the recommendation of the City's Historic Districts Study Committee and does not eliminate the locally designated historic district located at 1585 South Rochester Road.
