**SUBJECT:** Catch Basin Cleaning

## **REQUEST:**

City Council is requested to authorize a blanket purchase order to National Industrial Maintenance, Inc., Dearborn, Michigan for catch basin cleaning in the amount not-to-exceed \$160,000 through December 31, 2009.

### **REASON FOR PURCHASE:**

The City is required to performed stormwater catch basin cleaning including the removal, transportation and disposal of debris and non-potable water from catch basins located throughout the City. There are approximately 4,000 catch basins located within Rochester Hills, of which, up to 2,000 catch basins will be cleaned this year.

Preventative maintenance of the catch basins is required by the City's MS4 Permit as it relates to potential stormwater pollutant sources and their affects to water quality entering the MS4. Additionally, through the program the catch basins will cleaned of debris prior to the West Nile Abatement Program in 2009. All work performed under this contract will be in compliance with the City of Rochester Hills' MS4 Permit and MDEQ guidelines.

Request for Proposals were solicited, received and evaluated. National Industrial Maintenance, Inc. was selected as the lowest price and qualified contractor to perform catch basin cleaning throughout the City. The City has worked with National Industrial Maintenance, Inc. in the past and found their services to be satisfactory.
