**SUBJECT:** 2010 Landscaping Services and Lawn Mowing

## **REQUEST:**

City Council is requested to authorize the issuance of a blanket purchase order to Precision Landscaping, LLC for 2010 Landscaping Services and Lawn Mowing for City-owned sites in the amount not-to-exceed Sixty Four Thousand Eight Hundred Fifty (\$64,850.00) Dollars through December 31, 2010.

### **REASON FOR PURCHASE:**

City owned properties and boulevards are a highly visible component of the suburban landscape. It is important for the City to maintain the quality of its outdoor environment and natural features for the benefit of its citizens and to further enhance property values. The general appearance of these properties requires a level of maintenance for the proper landscape environment in order to preserve the citizens' investment in these properties.

The Purchasing Division solicited competitive sealed proposals for 2009 Landscaping Services, which were opened on March 10, 2009. Precision Landscape, LLC was selected as providing the best value and lowest cost proposed for landscape and lawn mowing services for the 2009 season. Precision Landscape LLC has performed the noted services in the past in a professional and satisfactory manner. The City of Rochester Hills wishes to exercise its option to renew for the 2010 season.

The not-to-exceed amount also includes funds to account for additional mowing due to weather conditions and other City events.
