

ORDINANCE NO. _____

AN ORDINANCE TO AMEND SECTIONS 54-741, 54-743, 54-744, AND 54-745; IN CHAPTER 54, FEES, OF THE CODE OF ORDINANCES OF THE CITY OF ROCHESTER HILLS, OAKLAND COUNTY, MICHIGAN, TO MODIFY FEES CHARGED FOR WATER; SEWAGE TREATMENT, NON-RESIDENTIAL WATER AND HIGH STRENGTH SURCHARGE, AND TO REPEAL CONFLICTING ORDINANCES, AND PRESCRIBE A PENALTY FOR VIOLATIONS.

THE CITY OF ROCHESTER HILLS ORDAINS:

Section 1. Section 54-741 of Chapter 54 of the Code of Ordinances of the City of Rochester Hills shall be amended as follows:

Sec. 54-741. – Bi-monthly water charges.

Bi-monthly (i.e., every 2 months) water supply charges, as provided in section 102-122, shall be as follows:

- (1) Customer charge \$ ~~2.90~~2.78
- (2) Commodity charge, for each 100 cubic feet of water 5.81
- (3) Fire line availability charge. There shall be a bi-monthly charge for each unmetered fire line connection for fire sprinklers and hydrant service, depending on size of the fire line, as follows:

Section 2. Section 54-743 of Chapter 54 of the Code of Ordinances of the City of Rochester Hills shall be amended as follows:

Sec. 54-743. – Sewage treatment bi-monthly charges.

Sewage treatment bi-monthly (i.e., every 2 months) charges, as provided in section 102-156, shall be as follows:

- (1) Customer charge \$ 2.902.78
- (2) Commodity charge:
 - a. Metered, for each 100 cubic feet..... 6.20
 - b. Nonmetered, flat rate per residential unit or unit factor..... 74.40

Section 3. Section 54-744 of Chapter 54 of the Code of Ordinances of the City of Rochester Hills shall be amended as follows:

Sec. 54-744. – Nonresidential surcharge.

The nonresidential surcharge for the water supply, as provided in section 102-157, shall be as follows:

Section 4. Section 54-745 of Chapter 54 of the Code of Ordinances of the City of Rochester Hills shall be amended as follows:

Sec. 54-745. – High strength surcharge.

The high strength surcharge, as provided in section 102-160, shall be as follows:

<i>Type of High Strength Surcharge</i>	<i>Total Charge Per Pound of Excess Pollutants</i>
Biochemical oxygen demand (BOD) in excess of 275 mg/l	\$0.50 <u>20.347</u>
Total suspended solids (TSS) in excess of 350 mg/l.....	0.51 <u>00.476</u>
Phosphorous (P) in excess of 12 mg/l	7.51 <u>96.368</u>
Fats, oils, and grease (FOG) in excess of 100 mg/l.....	0.48 <u>40.111</u>

Section 5. Severability. This ordinance and each article, section, subsection, paragraph, subparagraph, part, provision, sentence, word and portion thereof are hereby declared to be severable, and if they or any of them are declared to be invalid or unenforceable for any reason by a court of competent jurisdiction, it is hereby provided that the remainder of this ordinance shall not be affected thereby

Section 6. Penalty. All violations of this ordinance shall be misdemeanors and upon conviction thereof shall be punishable by a sentence of not more than ninety (90) days of confinement to jail or by a fine of not more than \$500, or both, in the court's discretion.

Section 7. Repeal, Effective Date, Adoption.

(1) Repeal. All regulatory provisions contained in other City ordinances, which are inconsistent with the provisions of this ordinance, are hereby repealed.

(2) Effective Date. This ordinance shall become effective on July 1, 2021 following its publication in the *Oakland Press* on _____, 2021.

(3) Adoption. This ordinance was adopted by the City Council of the City of Rochester Hills at a meeting thereof held on _____, 2021.
